GIVEN THAT

a following the establishment of selection for the activities of the AIDA Project, for the *Local Artistic Director for Coordination Board in Molise profile*,

ALL OF THAT

the parties agree as follows

1. Object, starting date, duration and consideration

Mr. Marco Caldoro undertakes in quality of *local artistic director for coordination board in Molise* to work in favor of the Fondazione Molise Cultura with reference to the 2ND CALL FOR PROJECTS IPA II CBC ITALY-ALBANIA-MONTENEGRO - TARGETED, as part of the AIDA project “Adriatic Identity through Development of Arts” the following activities planned in WP T1 “Analysis and definition of the Adriatic Identity Model”; WPT2 “Aida training from research to production”; WPT3 “Aida pilot action”:

- Activity: Artistic coordination of the activities of the AIDA project and aimed at the organization and monitoring of the cultural activities of all partners and in particular of the activities carried out in Molise.
- Deliverables:
 - o Deliverable D.T2.1.1 CB artistic coordination board
 - o Deliverable D.T3.1.1 Adriatic Identity model strategy, planning and results
 - o Deliverable D.T3.1.2 Audience development experience in Campobasso
 - o Deliverable D.T3.2.2 Production staged in Campobasso

This contract starts from the signing of this contract and has a duration until 31st December 2021, except for extensions to complete the activities.

In favour of the expert an all-inclusive fee of 100 euros per hour is established for a total of 60 hours which must be reported in a specific time sheet.

2. Method of carrying out

The activity referred to in paragraph 1 must be carried out:

- 1) in full collaboration with the other experts of artistic direction appointed by the project partners and the completion of the activity must take place within the agreed deadline;
- 2) the reporting of the activity and the payment of the consideration are quantified in hours, which must be reported in a specific time sheet.

3. Methods of payment

The remuneration will be paid upon presentation of regular invoices or work notes and detailed reports on the activities carried out and paid in the various periods indicated in the application form.

In consideration of the services performed under this contract the Partner Fondazione Molise Cultura shall pay to the contractor the sum of euro 6.000,00 , all taxes included.

This sum includes the travel and full accommodation costs that will be needed to carry out the activities.

4. Non-fulfilment and termination of the contract

If the results of the activity covered by the assignment are not compliant with what is required under this contract, Fondazione Molise Cultura requests the expert, within a period not exceeding 90 days, to integrate the activity carried out; failing this, Fondazione Molise Cultura can terminate the contract for non-fulfilment, without prejudice to the partial payment of the consideration.

5. Contractual discipline

For anything not expressly regulated by this agreement, the collaboration relationship must be understood as governed by the national laws.

6. Data processing

Pursuant to the regulations on the protection of personal data, the data provided will be processed only for purposes connected and instrumental to the management of the contract, in compliance with the national and international provisions in force.

7. Jurisdiction


For any dispute relating to the interpretation and application of this contract, the competent court is the Court of Campobasso
